**Posted Signs:**

- *We have a signed release form in the office.*
- *There are no other Bar None Arena events happening.*
- *There are no Bar None church services happening.*
- *You leave the arena the way you found it (Barrels, Gates, etc.)*
- *No alcoholic beverages allowed on the premises.*

## Arena Release:

- All riders using the arena **or any Bar None campus property** are required to have a signed Arena Release on file in the church office. (Arena Release forms can be obtained in the church office or on the church website.)
- The signed Arena Release form is good for one year
- An Arena Release form **does not apply** to any Bar None Arena Event; a separate release is required for events
- Minors (under 18) are required to have the signature of a parent or legal guardian

## Open Arena (Non-Bar None Arena Event Use):

The following applies to **all**, including those with **Tractor** and **Announcer Stand** access:

- See Exhibit A packet attached for the required forms to be completed prior to event
- The Arena is closed: Sundays - 9 am till 12 pm; Wednesdays - 6:30pm-8 pm; and during specially scheduled service times
- The Arena is closed to open riding during all Bar None Arena Events and the time involved in their preparation. If you are asked to leave due to this, please oblige our arena volunteers
- No profanity or abusive speech; ride for Jesus
- Be considerate and share equitably with other riders in the spirit of Christ
- There is no first come first served claim on arena use
- Empty arena of all barrels, poles, etc
- If livestock are present in the pens, do not enter pens or otherwise disturb livestock for any reason; If they do not belong to you, please leave them alone
- Follow all posted signs
- Have an up-to-date signed Arena Release on file in the office
- The arena tractor is not to be used for Open Arena or Non-Bar None Arena Event use
- The arena fans are not to be used for Open Arena or Non-Bar None Arena Event use unless pre-approved by Arena Team Leader.
- Keep all horses and livestock off the concreted area under the arena.
- There is a \$500 arena deposit required for all events which will be return in full if the following rules are abide by:
  - During your event and at the conclusion **ALL CHURH GROUNDS** must be free from litter and placing all trash in the dumpsters.
  - Trash container bags must be replaced in trash cans
  - The arena ground must be restored to as good or better condition than was previously found.
  - Any panels used must be taken up and stored back to their respectful place.
  - Bathrooms will be properly cleaned
  - Sidewalks will be swept and free of rocks and debris
  - Press box will be swept and trash removed and properly disposed of
  - All lights and fans must be turned off
  - In the event the concession stand is used all the above shall apply.

- Bar None agrees within 48 hrs. after the event to have a designated Bar None Arena team member inspect the grounds. If the grounds are acceptable to our designated team member the deposit will be refunded in full. The deposit may be returned in whole or in part dependent on the condition of the grounds after the event. In the case where there may be a dispute, Bar None's Arena Team will make the final decision after it confers with the outside event leader.

**Outside Organizations / Benefits:**

- All organizations wanting to use the Bar None arena must be approved by the Bar None Arena Team pending available dates
- The organizations that have been approved need to work with a Bar None Arena team member for preparation of the event.
- Must have a Gospel presentation by a speaker approved by the Bar None Elders or others given the authority.
- Only Bar None Arena address is approved to be used on promotional graphics from Outside Organizations / Benefits...No Church Logo.
- No promotion of Outside Organizations /Benefits from Bar None website, social media, or church announcements.
